SECTION C DESCRIPTIONS AND SPECIFICATIONS

Introduction and Background

Mentoring Network Program

The achievement of the Command's vision and mission depends on developing an agile, flexible, and responsive workforce. As the Command focuses on transforming into a competency aligned organization and innovating technical and business approaches, mentoring and coaching are essential components for employee managerial and leadership development. Developing mentoring partnerships will cultivate and preserve knowledge Command-wide, foster an environment of opportunity for all, leverage diversity to remove artificial achievement barriers, and demonstrate the value of the contributions of all employees. A formal mentoring program is a key business strategy to grow and manage our talent pool by assuring the civilian workforce and military personnel have access to subject-matter expertise at every point in their professional careers and to develop critical competencies required for current and future performance.

The Command-wide Mentoring Network Program encourages military and civilian personnel to participate as a mentor or mentee on a voluntary basis. The program provides the opportunity for communication and interaction between employees at different levels, within and across competency domains, at NAVSEA Headquarters and at Field Activities, in an effort to provide opportunities to share organizational knowledge and experience.

The Program mission is to promote a mentoring culture that fosters personal growth and professional development resulting in increased workforce diversity, readiness, retention and accountability. To achieve this mission and support Command-wide program implementation, NAVSEA's mentoring program objectives are to: (1) develop a diverse workforce of leaders whereby senior executives or managers share their experience, knowledge, and insight with new supervisors and employees; (2) provide new employees a structured but personalized method to acquaint them to the Department of the Navy and the Command; (3) afford accessibility to the organization's collective experience, wisdom, values, and culture; (4) foster a Command-wide collaborative environment to increase functional learning and knowledge sharing, and to promote diversity of thought and skill; (5) link employees with real time knowledge and best practices to reduce the learning curve on organization projects/business initiatives; and, (6) support a multicultural workforce by creating partnerships among diverse employees and allowing equal access to mentoring.

Mentoring partnerships are defined as a reciprocal learning partnership in which the mentor and mentee develop a written agreement where they will work collaboratively toward achievement of mutually defined goals/outcomes by sharing experiences and expertise to guide personal growth and professional development. A partnership may be self-selected, decided by a third party, or established through a systematic matching process.

There are various types of mentoring program partnerships that serve the needs of the workforce. They are:

One-on-One mentoring that involves two individuals, each with areas of expertise and contribution, who collaborate to achieve developmental or learning goals.

Virtual Mentoring depends on the primary mode of communication between the mentor and mentee through the use of electronic tools. These tools include email, online meeting platforms, videoconferencing, telephone, voicemail, and faxes. Virtual mentoring is intended for partnerships not co-located. This allows mentoring partnerships to be formed between parties at different NAVSEA field activities.

Mentoring Circles consist of one or more mentors who work with a group of mentees, to pursue a range of both structured and non-structured activities.
